

## **Terms & Conditions**

### **1. General**

1.1 The following Terms & Conditions apply to all members at Warwick Golf Centre and where appropriate all visitors.

1.2 By paying an annual subscription or greenfee you agree to accept these term & conditions.

1.3 These terms & conditions may be changed at any time and without prior notice. The latest version will be that which is published on the Warwick Golf Centre website. ([www.warwickgolfcentre.co.uk](http://www.warwickgolfcentre.co.uk))

1.4 Memberships are non-transferrable and non-refundable.

1.5 Membership of Warwick Golf Centre entitles you to use the facilities for that membership year in accordance with the rights and restrictions applicable to your membership category.

1.6 Granting of membership does not imply an automatic right to renew membership in subsequent membership years.

1.7 We reserve the right to limit the number of members in any given membership category, to amend the allocation of exclusive member tee times or to close the course at any time. Any such decision will not be made unreasonably but may be made at the sole discretion of Warwick Golf Centre.

1.8 Data Protection. You consent to our use of the information given by you, including your personal information, for the administration of your membership and our marketing purposes. We will not pass on your information to third parties for marketing purposes.

### **2. Payment of Subscriptions**

2.1 Renewal subscription payments are due on the first day of the relevant subscription year. If not paid in full in cleared funds by this date, then you will be deemed to have not renewed and all membership rights will cease immediately. Should you wish to become a member subsequently you will have to reapply for membership.

2.2 Full membership is for a fixed period of 1 year. Where membership is paid by an agreed payment scheme such as monthly direct debit or similar agreed scheme you are agreeing to pay the full amount for the whole 12 month period, when an agreed payment scheme is stopped the club has the right to apply to the member for the outstanding balance in full.

2.3 All memberships payments received are subject to a customer 14 day cooling off period.

2.4 If paying by direct debit or any other agreed payment scheme then failure to meet the agreed payment schedule will result in the suspension of your membership, no refunds will be given for payments made up to that point, the remaining balance will be due immediately and you may lose your right to pay by instalments in the future.

2.5 In the event of termination of membership within the membership year, for whatever reason there will be no refund of membership subscriptions.

2.6 Membership subscriptions do not include any insurance products or golf union fees.

### **3. Membership Categories**

3.1 Full Member. Unlimited golf 6.5 days per week (excluding Sunday mornings). Sunday mornings may be included with participation in club competitions after paying in full any additional fees.

3.2 Senior Member. Unlimited golf Monday to Friday teeing off before 3pm.

(Men 65yrs. Ladies 60yrs)

3.3 Junior Member. Unlimited golf 6.5 days per week (excluding Sunday mornings).

Sunday mornings may be included with participation in club competitions after paying in full any additional fees.

(16yrs and under)

### **4. Use of the Course**

4.1 Members must register to play in the clubhouse before playing.

4.2 Members must make themselves aware of any local rules in place before playing.

4.3 General golf etiquette must be observed at all times including avoiding slow play and being courteous to all other golfers on the course.

#### **5. Equipment and Property**

5.1 Members will be held liable for any costs incurred to any fixtures, fittings, property or equipment belonging to Warwick Golf Centre, the surrounding properties while visiting Warwick Golf Centre or any other member or visitor to Warwick Golf Centre which has been deliberately, negligently or wantonly damaged.

#### **6. General Liability**

6.1 Warwick Golf Centre cannot be held responsible for any loss or damage to members or visitors property whilst at Warwick Golf Centre.

6.2 The golf course and surrounding areas are a natural environment, with many different types of terrain and landscape and there can be unexpected conditions under foot. Whilst all efforts are made to make this as safe an environment as possible Warwick Golf Centre cannot be held liable for any injury caused by slips, trip or falls or any other such incident whilst on the premises.

#### **7. Breach of Terms & Conditions**

7.1 Any breach of these terms & conditions or conduct in a manner that is prejudicial to the best interests of Warwick Golf Centre, including behaviour that is rude or offensive to staff, members or visitors, will result in disciplinary action by Warwick Golf Centre and could result in the termination of membership.

7.2 A decision to take disciplinary action and the level of sanction imposed shall be decided by the Management.

7.3 Any sanctions taken against an individual for a breach of these terms and conditions is done so at the sole discretion of the management of Warwick Golf Centre and following consideration of any appeal by the individual to the management any decision will be final.
